Payment for all Hot Shots, Junior Groups, Squads, Private sessions must be paid in full upfront no later than the due date. Payment for Private lessons of 45 minutes or more is preferred upfront also for the Term. However due to the cost it can be paid in Split Term intervals (beginning & mid-way through Term) or on a weekly basis if required. Failure to pay by the due date will result in a late charge fee of \$10 .

Notice of cancellation of enrolment must be received in writing to McNamara Tennis . No refunds will be given under any circumstance. Credit towards next Terms coaching may be provided in some instances at the Director's discretion . All Hot Shots, Junior Groups, Squads, Match Play and Cardio Adult Group session participants must provide a minimum of 24 hours notice to JP MCNAMARA if unable to attend scheduled class. Make up lessons will be provided to all Hot Shots, Junior Groups and Squad session participants provided this required notice is given. For Cardio Adult Group and Match Play, make up lessons will also be offered if the required notice is provided, however due to limited make up option times, credit to next Terms coaching may be offered to participants if make up lessons are not feasible.
